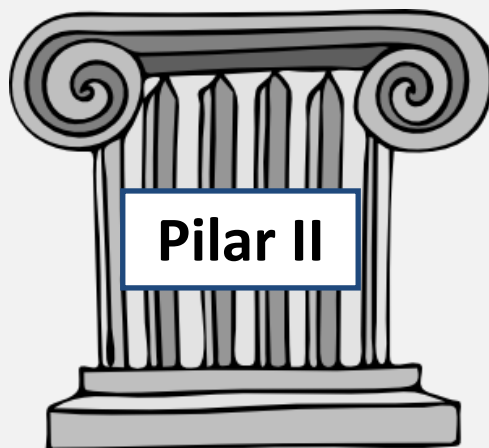

Objectivo do Desafio Societal 6

"To foster a greater understanding of Europe, provide solutions and support inclusive, innovative and reflective European societies in a context of unprecedented transformations and growing global interdependencies"

(Para promover uma maior compreensão da Europa, dar soluções e apoiar sociedades europeias inclusivas, inovadoras e reflexivas num contexto de transformações sem precedentes e de interdependências globais crescentes.)

DS6 2014-2015 estruturado em torno de 5 *calls*

- 1. Overcoming the crisis (strategies and governance structures for Europe) – 40M€**
- 2. The Young generation (labour market, mobility, inclusion) – 15M€**
- 3. Reflective Societies (cultural heritage and European identities) – 50,5M€**
- 4. Europe as a global actor (supporting EU external policies & increasing international cooperation) – 43,7M€**
- 5. New forms of innovation (business models, social innovation, public sector innovation) – 84,17M€**

Definição das *calls*

1. **Overcoming the crisis**: estabilidade económica; reforma da governança económica da UE; consequências sociais da crise.
2. **The Young generation**: desafios actuais dos jovens – desemprego, mobilidade, mudança.
3. **Reflective Societies**: identidade e memória da UE; união na diversidade; tecnologias digitais para facilitar o entendimento da herança cultural europeia.
4. **Europe as a global actor**: fortalecer o papel da UE como actor-chave; estimular a participação de países terceiros no H2020.
5. **New forms of innovation**: inovação no sector público e novos modelos de negócio; divulgação sobre o impacto da adopção de tecnologias na educação e formação.
